3:30 PM - 4:00 PM - Hudson Access Project Beta Map - Chris

• Sara Eichner from Pratt Institute began to speak about the latest efforts around the Hudson Access Map Project, which is collecting information about all the places where the public can get into and onto the water in the Hudson & Harbor Estuary and its tributaries.

- project has had some challenges collecting data has been difficult. Survey has been distributed
 which was sent to park managers and others but it's been hard to get people to follow through
 with it.
- More effective way to build dataset has been desktop research via google searches and comparing of existing data and on the ground data validation
- Trying to focus areas that are red meaning underserved
- Red areas only have names and not alot of in instead of showing current wq data they've added info on how heavy rain can impact water access sites under rainfall
- Water safety right now just has info on water temperatures. But will include info tide gauges
- Map now working: you can look through map or list for all the places/sites included
- First preferred method of data collection was for people to operate the site to fill it out but haven't been successful in that

4:00 PM - 4:30 PM: Overview of Weequahic Park Association - Liz or Allison

- Weequahic Park Association's Executive Director and new addition to the CAC leadership,
 Wynnie-Fred Victor Hinds, will highlight WPA's dedication to the restoration and preservation of Weequahic Park located in the city of Newark.
- WPA located in sout ward of Newark one of the oldest and most successful grassroots poc led park support and advocacy organziations
- Has been around for 30 years have a partnership agreement with Essex county
- Model themselves after central park even though they have nithing close to their resources
- Recently WPA has come to receive a few grants between private foundations and city grants.
 Other grants include TNC proposing sensory garden mostly geared towards children and disabled to encourage to spend time outdoors
- Goals of park is to be welcoming of everyone and not just residents -
- Homestead network and you would think it could encourage park restoration
- Some metrics wynnie hopes on using tally on metrics from parks affairs and community meetings.
- Another grant being proposed by WPA prioritizes nature based solutions as a flood management practices.
- some challenges: fish being caught from the lake and eating it
- Links around nidep lake management support were shared
