NEW YORK-NEW JERSEY HARBOR & ESTUARY PROGRAM

Program Support for an Artist in Residence Program on the Harlem River

August 23, 2024

The New York-New Jersey Harbor & Estuary Program (HEP) is requesting expressions of interest from Bronx-based arts organizations to provide programmatic support for an Artist in Residence program for the Harlem River. The Artist in Residence (AIR) is a pilot initiative funded by the Environmental Protection Agency (EPA) to address critical water quality challenges. It was developed in response to President Biden's Executive Order (EO) on Arts and Humanities (EO 14084 Promoting the Arts, the Humanities, and Museum and Library Services, October 5, 2022). EPA is supporting HEP and the Bronx & Harlem River Urban Waters Federal Partnership location (BxH UWFP) to demonstrate how arts and culture can help inform efforts to work more effectively with communities, build understanding of water quality and other environmental concerns, build stronger connections between communities and natural resources, and better meet communities' unique needs. The Hudson River Foundation (HRF) hosts HEP and the BxH UWFP and will be the contracting entity for this request for expression of interest (RFEI).

A total of \$20,000 is available under this RFEI. HEP anticipates making up to two grants totaling \$ 20,000 for Bronx-based arts organizations to support the Artist in Residence Initiative between October 1, 2024 and March 1, 2026. Grant recipients must be a unit of local government or non-profit organization located in and/or serving the communities along the Harlem River in the Bronx.

The Request for Expressions of Interest (RFEI) is due September 19, 2024. We will invite a small number of the most promising applicants for interviews by September 26, 2024 with a final selection by October 10, 2024.

I. Program Background

The New York New Jersey Harbor Estuary is a complex ecological system at the heart of the nation's largest metropolitan area. The New York - New Jersey Harbor & Estuary Program (HEP) engages people, partners, and communities to collaboratively advance understanding, improve stewardship, and enhance our shared waters and watersheds.. Created by the U.S. Environmental Protection Agency (EPA) at the request of the governors of New York and New Jersey, HEP is an ongoing collaboration to develop and implement a consensus driven plan to protect, conserve and restore the estuary. HEP decisions and activities are carried out by staff and partners organized through committees and work groups. One of these is the Bronx and Harlem Rivers Urban Waters Federal Partnership (BxH UWFP), which connects community-based organizations and public agencies to help overburdened and underserved Bronx communities reconnect to their waterways, improve water quality and human health, and restore impacted riverfronts while pursuing environmental justice. The [Hudson River Foundation \(HRF\)](#) hosts HEP and will be the contracting entity for this RFEI. HRF's mission is to inspire and inform action through science and engaging people to enhance the Hudson River, estuary and watershed.

II. Project Background

[EPA's Artist in Residence \(AIR\)](#) pilot initiative to address critical water quality challenges is intended to demonstrate how arts and culture can help inform efforts to work more effectively with communities, build understanding of water quality and other environmental concerns, build stronger connections between communities and natural resources, and better meet communities' unique needs. The EPA AIR pilot, in partnership with the National Endowment for the Arts (NEA), will support a broad range of local artists and culture bearers in six geographic areas within National Estuary Programs (NEP) and Urban Waters Federal Partnership (UWFP) locations. Select local artists and culture bearers are being asked to help boost local engagement, awareness of estuaries, and participation in addressing critical water challenges, consistent with the goals and objectives of HEP's Action Agenda and the Bronx & Harlem UWFP location workplans.

HEP and the BxH UWFP anticipate issuing a Request for Qualifications (RFQ) in the fall of 2024 to identify qualified Bronx artists. We expect that up to \$75,000 will be made available for an artist(s) to:

- Immerse themselves in the water quality and other environmental challenges facing the Harlem River and local communities (Winter 2025);
- Conceptualize one or more creative projects and discuss them with the project committee (Spring 2025);
- Implement the selected project(s) and document the work and the process (Summer and Fall 2025); and
- Participate in evaluation of this pilot initiative (Winter 2026).

The funds can be used to support artist fees, travel, equipment/supplies, fabrication, installation, and documentation of the art. Funds can also be used for signage, insurance, and other services required to support creation, permitting, installation, and community programming. HEP staff will administer this overall process and provide background information and connections for the artist to gain

understanding of the Harlem River and its management issues. Together with local partners, including the selected arts organization, HEP will organize, staff, and otherwise create community and regional events that will provide an opportunity to showcase the artist and their work, including City of Water Day in July 2025, the Harlem River Community Festival in October 2025, the annual HEP Conference in November 2025, and other Bronx venues/events to be determined. The EPA/NEA Headquarters Team will provide national level guidance and opportunities for shared learning and reflection across the six locations across the country.

Through this RFEI, HEP anticipates partnering with one or two Bronx-based arts organizations with deep experience and knowledge of arts programming and the artistic community in the Bronx. Ideally the arts organization would also have prior experience conducting an artist in residence program. The selected organization(s) would be full partners in this effort, helping shape the RFQ, selecting the artist(s), and showcasing the artist's creative work. The RFQ and overall project would be co-branded as a partnership effort.

III. Artist in Residency Project Objectives

The selected organization(s) will partner with HEP and the BxH UWFP to support HEP, the BxH UWFP, and the selected artist in meeting the following objectives of the AIR project:

1. **Express data, science and/or community knowledge** that elevates the understanding and appreciation of the Harlem River's ecology, water quality, the impacts of current and past uses of the waterway, and impacts of climate change.
2. **Articulate the values of environmental justice**, including the history of the Harlem River, the overburdened communities along its shores, policies and practices that led to the degradation of the river, and loss of utility by the public.
3. **Celebrate parks, public spaces, and other improvements** that are improving access to the Harlem River and / or enhancing water quality, enhancing habitat, and building climate resiliency.
4. **Engage community members** and especially young people and students in forthcoming planning and decisions about the management of the Harlem River and /or specific infrastructure projects being advanced by federal, state, and local agencies.
5. **Demonstrate the power of collaboration** between community, government, independent scientists, and/or utilities.

IV. Roles and Responsibilities of the Selected Bronx Arts Organization

The roles and responsibilities of the selected organization(s) selected through this RFEI are listed below. Please note that that some of these roles/responsibilities are marked as optional. Our evaluation of applicants will recognize the overall experience and capacities of arts organizations; Potential ability to provide these specific services will be just one consideration.

1. Review and advise on the request for qualifications (RFQ) for artists
2. Assist with distribution of RFQ to arts community
3. Be part of review panel and selection of the artist

4. Provide workspace for the artist (optional)
5. Provide contacts and engagement opportunities for the artist with other Bronx artists and the community
6. Provide the artist with information and access about selected public spaces to present the arts appropriate
7. Help secure permissions and any required permits for the performance, installation, and programs as needed and appropriate (optional)
8. Include opportunities for artist to participate in specific public programs as appropriate
9. Social media/marketing/communications for residency program
10. Participate in evaluation of the AIR program

V. General Guidelines for Applicants

Eligibility: Applicants must be non-profit organizations with 501(c)(3) status or local government entities located in or otherwise serving located in and/or serving the communities along the Harlem River in the Bronx. Organizations without 501(c)(3) status may apply, but they must partner with a local government entity or another organization with 501(c)(3) status that will serve as a fiscal agent for the project/proposal.

Funding: A total of \$20,000 is available under this RFEI. HEP anticipates making one or two grants totaling \$20,000.

Once an award is made and a contractual agreement is signed, grantees will receive an advance of 50% of the total grant. Subsequent payments will be paid based on one or more milestones identified in the AIR Project Timeline below as well as submission and approval of the final report. Funds can be used to support salary, fringe, travel, equipment/supplies, professional services, and other direct costs. Indirect costs of up to 40% of staff costs are allowed. Food costs are ineligible.

Match: No matching funds are required, but contribution of outside funds, in-kind services, or other match will be favorably reviewed and should be indicated in the Budget Form.

Deliverables and Conditions: Award recipients are required to complete tasks in a timely manner pursuant to the AIR Project Timeline and submit a brief final report together with the final invoice.

Prospective applicants are invited to submit an expression of interest as described below. The expressions of interest should be submitted via this Google form link by no later than 11:59 PM EST September 19, 2024. (See below all requirements and an attached list of the questions in Appendix A).

Invitations for Interview (September 26, 2024)

We will be inviting a small number of applicants submitting an expression of interest to meet virtually for an interview to determine best fit. The selected applicants will be notified by end of day September 26th and asked to meet sometime the week of September 30th.

Grant Awards/Contracts (Anticipated October 10, 2024)

HEP will work with the successful applicant(s) to develop the final scope(s) of work. Once approved, HEP expects to provide contracts to the selected applicant(s) on or about October 10, 2024. Projects cannot start until both parties sign the contract. HEP and HRF reserve the right to modify, postpone or cancel this solicitation and to reject all applications.
